Round table n° 1 : DASTRI, 10 years already!

The speakers will present the context of the creation of EPR for sharps waste and its evolution over the last ten years. Particular emphasis will be placed on its role during the pandemic, in support of public health policies.

- ∇ Within the framework of the Grenelle de l'Environnement, the **local authorities** were at the initiative of the creation of the sector. What were their motivations? What is their assessment after a decade of operation?

- ∇ The smooth running of the system depends above all on the **patients'** support. How has this system changed their lives? What are their expectations?

- ∇ **Pharmacists**, after some reluctance, have been largely mobilised and have contributed to the success of the sector. How do they perceive this new and evolving part of their profession today?

- ∇ The participation of the **marketers** has made it possible to reduce the mental burden on patients without any additional costs for them. How did they go beyond this regulatory obligation and work to create value?

Marie Pene-Marie, Head of Medical – Public Affairs and Training (Roche Diabètes Care)

- ∇ The **Ministry of Health** relied on the sector at the height of the pandemic to respond to the urgent need to manage the DASRI produced in pharmacies as part of the national screening and vaccination strategy. What conclusions can be drawn from this difficult period?

Round table n° 2 : Health EPR on the move

Although France is the only country to have set up a national EPR system for sharps waste, other countries have initiated or are about to initiate similar processes, particularly in Europe, North and South America.

- ▽ **Canada** has set up an EPR system combining medications and sharps at the provincial level. The eco-organisation will present the context in which this system was set up, its current status and its challenges, particularly in terms of exchanging best practices with the DASTRI system.

- ▽ In the **United States**, there are mandatory EPR systems in California and voluntary programmes in Oklahoma and Missouri. PSI, a non-profit organisation that has contributed to the enactment of 130 EPR laws in 33 states since 2000, will present a state of play on medical waste.

- ▽ In Latin America too, the REP are on the move. An update will be given on the situation with a focus on Chile. The creation of a transnational discussion space that will foster knowledge of the different medical device waste management systems around the world from both a legal and technical point of view and the interest in developing transnational partnerships will also be discussed.

- ▽ In Europe, **Portugal**, which already has an EPR system for used medical devices, is considering the possibility of extending its scope to include used perforating medical devices. The eco-organisation will present the reasons that led it to this reflection and the interest in developing transnational partnerships based on the model of the *Red Iberoamericana*, which includes Portugal, Spain, Colombia and Mexico.

Round table n° 3 : What is the outlook for 2023-2028 ?

The new framework set by the State encourages experimentation and innovation. Companies have already taken up the challenge of the circular economy in the health sector, either individually or collectively.

- ▽ The French Public Health Code authorises the **recycling of the body of pre-filled injectable pens** used by self-treatment patients since 1 January 2022 and for five years. Novo Nordisk will present the Returpen project and more broadly the company's approach entitled Circular for Zero.

- ▽ Initially individual, the separation for recycling of medical devices with electronics has become a collective adventure now regulated by the environmental code (2021). The company, a pioneer in this field, will present the experimentation and the reasons that led it to commit to this approach.

- ▽ Article 72 of the AGECL (the anti-waste law for a circular economy) now requires companies whose products are subject to the EPR principle "to draw up and implement a prevention and ecodesign plan [...]". The expectations of users and

prescribers have become unavoidable in this area and will be illustrated by the company Dexcom.
